BYLAW NUMBER 79 2024 TAXATION BYLAW

PREAMBLE:

Bylaw 79 is a bylaw for imposing taxes upon lands in Fletcher Creek Improvement District, and to provide for imposing a percentage addition to encourage prompt payment thereof.

Bylaw 79 is to repeal 2024 Taxation Bylaw 78.

The Trustees of Fletcher Creek Improvement District ENACT AS FOLLOWS:

1. For the year 2024 there is hereby levied the following taxes:
 - a. Group 1: A tax of \$584.83 on each and every Parcel of land.
 - b. Group 2: A tax of \$584.83 on each and every Parcel of land.
 - c. Group 3: A tax of \$976.67 on each and every Parcel of land.
 - d. Group 4: A tax of \$1,169.67 on each and every Parcel of land.
 - e. Group 5: A tax of \$1,362.66 on each and every Parcel of land.
 - f. Group 6: A tax of \$1,561.51 on each and every Parcel of land.
 - g. Group 7: A tax of \$1,754.50 on each and every Parcel of land.
 - h. Group 8: A tax of \$1,169.67 on each and every Parcel of land.
 - i. Group 9: A tax of \$2,339.33 on each and every Parcel of land.
 - j. Group 10: A tax of \$584.83 on each and every Parcel of land.
2. The aforementioned taxes shall be due and payable on or before midnight, the 2nd day of July, 2024 and shall have a percentage addition of 20% added to all taxes remaining unpaid after the said date.
3. In addition, taxes remaining unpaid on the 1st day of March, 2025, shall bear interest at the rate prescribed by the Lieutenant Governor in Council under the Taxation (Rural Area) act, as set out under Section 760 of the Local Government Act.
4. This bylaw may be stated as the "2024 Taxation Bylaw"
5. 2024 Taxation Bylaw 78 is hereby repealed.
