## BYLAW NUMBER 62 – Taxation Bylaw, 2016

A bylaw for imposing taxes upon lands in the improvement district, and to provide for imposing a percentage addition to encourage prompt payment thereof.

The trustees of Fletcher Creek Improvement District ENACT AS FOLLOWS:

1. For the year 2016 there is hereby levied the following taxes:
  - a) Group 1: A tax of \$ 512.98 on each and every Parcel of land.
  - b) Group 2: A tax of \$ 512.98 on each and every Parcel of land.
  - c) Group 3: A tax of \$ 856.68 on each and every Parcel of land.
  - d) Group 4: A tax of \$ 1,025.96 on each and every Parcel of land.
  - e) Group 5: A tax of \$ 1,195.24 on each and every Parcel of land.
  - f) Group 6: A tax of \$ 1,369.66 on each and every Parcel of land.
  - g) Group 7: A tax of \$ 1,538.94 on each and every Parcel of land.
  - h) Group 8: A tax of \$ 1,025.96 on each and every Parcel of land.
  - i) Group 9: A tax of \$ 1,882.64 on each and every Parcel of land.
  - j) Group 10: A tax of \$ 410.38 on each and every Parcel of land.
2. The aforementioned taxes shall be due and payable on or before midnight, the 30<sup>th</sup> day of June, 2016 and shall have a percentage addition of 20% added to all taxes remaining unpaid after the said date.
3. In addition, taxes remaining unpaid on the 1<sup>st</sup> day of March next following the date upon which the taxes are levied, shall bear interest at the rate prescribed by the Lieutenant Governor in Council under the Taxation (Rural Area) act, as set out under Section 760 of the Local Government Act.
4. This bylaw may be cited as the "Taxation Bylaw 2016."
